    - Department of Juvenile Justice – Summer Programs Preventing Juvenile Delinquency to support five youth empowerment centers (West Palm Beach (2), Riviera Beach, Lake Worth, and Belle Glade). Total grant amount is \$188,406.
    - Office of Juvenile Justice and Delinquency Prevention - Second Chance Act grant for Juvenile Reentry in the amount of \$750,000 for supportive housing for juveniles returning home from moderate to high risk facilities.
    - Criminal Justice Mental Health and Substance Abuse Reinvestment Grant to increase public safety and treatment for adults and juveniles with mental health and substance abuse issues. Total grant amount is \$1,200,000 for three years.
