Palm Beach County Days



Last week lawmakers returned to the Capitol for the 2022 legislative session. And they were not the only ones – after last year's virtual event, Palm Beach County (PBC) residents also returned to Tallahassee for Palm Beach County Days.

Although there are no current safety protocols or restrictions in place at the Capitol, the PBC team scheduled meetings by taking room size, number of individuals and preference or virtual meetings into consideration.

A big thank you to all the Commissioners, County Staff, municipal partners and business leaders who joined us in Tallahassee. Together we presented our issues with a united front.

Week 1: Legislation

Some bills moving in week 1 included:

- **SB 760 Human Trafficking:** Passed its first of three committees, with Commissioner McKinlay testifying in support of the bill.
- **SB 512 Vacation Rentals:** Passed its first of three committees. This year's bill picks up where we left off last year; allowing local governments to conduct registrations with fee limits, but preempting platform regulation to the state.
- SB 280/HB 403 Local Ordinances: This bill would require a county commission to prepare a business impact estimate prior to the enactment of a proposed ordinance and provides for attorney fees limitations. FAC has been working with the Senate sponsor, and an amendment offered this week did address several concerns we had. But there is more work to do. The Senate bill passed its first of two committees on Wednesday. The House bill has two more committee stops.
- **HB 195 Juvenile Diversion Expunction:** Passed its first House committee on Wednesday and has two more committee stops.
- **HB 197 Non-Judicial Arrest Record of a Minor:** This public records exemption bill passed its first committee and has two more stops.
- **SB 494 Fish and Wildlife Conservation Commission:** This bill which contains helpful language to address derelict vessels passed its second committee on Wednesday and move on to the Appropriations Committee.
- HB 569 Business Damage Caused by Local Governments: This is the major preemption bill of the session, allowing for businesses to sue local governments for proven loss of profit due to effects of local ordinances. Commissioner McKinlay, FAC and county staff met with the House sponsor on Wednesday. The bill passed its first committee 12-5 with many questions from the minority members. The Senate bill was removed from the Rules Committee this week by leadership, so it only has a stop in the Appropriations Committee remaining. We are told the is a priority of the Senate President.

Week 2: Bill Watch List

SB 690 Resilience-related Advisory Committees - Permits certain resilience-related advisory committees to conduct public meetings and workshops by means of communications media technology pursuant to the rules of the Administrative Procedures Act. This bill is on the committee agenda - Community Affairs: Tuesday, 01/18/22, 3:30 pm. Current PBC Position: Support

SB 1194 Local Tax Referenda Requirements - Requires referenda authorizing certain optional local taxes to be held at a general election: Tourist development tax, Areas of critical state concern tourist impact tax, Children's services independent special district tax, County temporary excess ad valorem millage, Municipal temporary excess ad valorem millage, County transportation motor fuel tax, Local option fuel taxes, and School district millages. Presently, the referenda approving the above local taxes are held at elections called by the applicable local governing body. This bill is on the committee agenda - Community Affairs: Tuesday, 01/18/22, 3:30 pm. Current PBC Position: Monitor

SB 838 Fire Investigators - expands the definition of "firefighter" related to cancer diagnoses for firefighters, making a fire investigator eligible for benefits under the statute. This bill is on the committee agenda - Community Affairs: Tuesday, 01/18/22, 3: 30 pm. Current PBC Position: Monitor

SB 1150 Tax Exemption for Affordable Housing – Provides that a county or municipality may adopt an ordinance to grant an ad valorem tax exemption to any property owner whose property is used to provide affordable housing in a multifamily project with at least 50 dwelling units. This bill is on the committee agenda - Community Affairs: Tuesday, 01/18/22, 3:30 pm. Current PBC Position: Monitor

SB 1326 Comprehensive Review Study of the Central and Southern Florida Project - Requires the South Florida Water Management District (SFWMD) to prepare and submit a consolidated annual report regarding the status of the Comprehensive Review Study of the Central and Southern Florida Project (Restudy) to the Office of Economic and Demographic Research, the Department of Environmental Protection (DEP), the Governor, and the Legislature. This bill is on the committee agenda – Environmental and Natural Resources: Tuesday, 01/18/22, 9:00am. Current PBC Position: Support

Preemptions

HB 717 Agritourism - Prohibits the denial of an agricultural land classification solely due to the conduct of an agritourism activity. Qualifying lands under the agricultural land classification are allowed lower tax assessments. The Revenue Estimating Conference noted that the bill may have an insignificant negative fiscal impact on local governments. This bill is on the committee agenda - Environment, Agriculture & Flooding Subcommittee: Tuesday, 01/18/22, 4:30 pm. Current PBC Position: Oppose

SB 280 Local Ordinances – Adds to the process for local governments passing ordinances and gives certain additional rights to those challenging local ordinances, requiring cities and counties to produce a "business impact estimate" prior to passing an ordinance. Additionally, the bill imposes certain conditions on lawsuits brought to challenge local ordinances as preempted by the State Constitution or law, arbitrary or unreasonable. Article VII, section 18 (a) of the Florida Constitution provides in part that a county or municipality may not be bound by a general law requiring a county or municipality to spend funds or take an action that requires the expenditure of funds unless certain specified exemptions or exceptions are met – none of the exceptions appear to apply here. This bill is on the committee agenda – Rules: Thursday, 01/20/22, 9:30am. Current PBC Position: Oppose, but working with sponsor.

SB 620 Local Government - Creates a cause of action for an established business to recover loss of business damages from a county or municipality whose regulatory action has caused a significant impact on the business. This new cause of action is not tied to real property ownership. This bill is on the committee agenda - Appropriations: Thursday, 01/20/22, 11:30 am. Current PBC Position: Oppose.

SB 518 Residential Home Protection – Amends a provision in a law prohibiting a local government from requiring a notice to trim or remove a tree on a residential property if the property owner has documentation that the tree presents a danger to those on the property. This bill is on the committee agenda - Community Affairs: Tuesday, 01/18/22, 3:30 pm. Current PBC Position: Oppose
