FREQUENTLY ASK QUESTIONS (FAQs)

1. Is completion of all the trainings an annual requirement? **It depends. Ask the Contract Manager.**
2. Are administrative staff who do not provide direct client services required to take, Trauma Informed Care/ACES, MI and Wraparound training? **No, only staff who provide direct client services are required to take Trauma Informed Care/ACES, MI and Wraparound training.**
3. Are there alternatives to the 2-day REI Racial Equity training that will fulfill the Racial Equity Training requirement? **Yes, an alternative to the 2-day REI training is the bi-annual Racial Wealth Gap Training, provided by Community Action Program and other training sites listed in the chart above.**
4. Is staff training time billable via our County contract? **Yes, it is built into the unit rate.**
5. Are the costs for County required trainings reimbursable? **Yes, under Administrative costs, which are built into the unit rate.**
